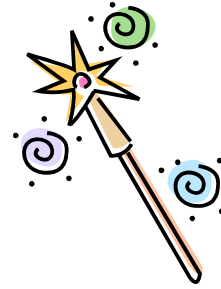


UPDATED February 2, 2010



Hello Nevada Rainbow –

California Grand Assembly time is almost here. The “Happily Ever After – A Fairy Tale End in 2010” **Grand Assembly** Sessions will be March 27 - 30, 2010 in Fresno, California. We will stay at the Radisson Hotel for 4 nights and be there from Opening on Saturday until the completion of Installation on Tuesday afternoon. It would be nice for everyone to stay through Installation but it is okay if there are people who need to return home earlier.

ALL REGISTRATIONS ARE DUE TO ME NO LATER THAN FEBRUARY 12, 2010.

The **ACTUAL** costs for California Grand Assembly are:

- Housing at the Radisson Hotel is **\$115.36** (*including tax*) per night for 1 to 4 people per room.
- Registration/Special Event on Saturday, March 27th that includes dinner and VIP Dinner on Sunday March 28th – **\$125.00 (at Mrs. Jacka’s request all 3 must be purchased together, no one is to be left behind)**
- Line Officers Luncheon – Sunday, March 28th – 12noon at the Radisson Hotel – **\$19.00** – Grand Officers should attend, as well as all girls and adults.
- Grand Cross of Color Breakfast – Monday, March 29th – 8:45am at the Radisson Hotel – **\$17.00** – all holders of the Grand Cross must attend.
- **All other meals are on our own....as a group!** and perhaps a little time in the local mall. Please plan accordingly and bring enough money (about \$100.00) for the following meals - Breakfast on Saturday, Sunday, Monday and Tuesday unless you are attending Grand Cross and then you only have 3 additional breakfasts. Lunch on Saturday, Monday, and Tuesday. Dinner on Friday, Monday and Tuesday.
- **TRANSPORTATION** will also be on your own. We plan to travel as a group to and from California Grand Assembly. We will leave from Reno Friday evening at 5pm from the McDonalds at Mae Anne and McCarran and will leave for home from Fresno on Tuesday about 4:00pm after the Installation. The travel time between Reno and Fresno is about 6 hours in good weather.
